The implementation of the Private Hire Vehicles (London) Act 1998 necessitated the development of infrastructure to support the annual licensing of Private Hire Vehicles (PHV). Due to its in-depth knowledge in the automotive domain, SGS was chosen as the partner.



Provogue, one of India's leading garment retailers, wanted SGS to strengthen its existing product line through introduction of more stringent test parameters throughout the supply chain.


